

LITITZ BOROUGH COUNCIL
Minutes of Reorganization Meeting Held January 3, 2022
7 S. Broad Street, Lititz, PA

The January 3, 2022, reorganization meeting of the Lititz Borough Council was conducted as a hybrid meeting, in person in Council Chambers and virtually utilizing Zoom, which is a cloud-based platform for remote video and audio conferencing. The meeting was called to order at 7:00 P.M. by Mayor Snyder who had been sworn in to office earlier in the day by District Justice Edward Tobin, having been duly elected to the position of Mayor. The following Council members were present: Brubaker, Greiner and Weaver. Others in attendance were Council-elect Stephen Lee, Council-elect Kendrick Mobley, Council-elect Christine Sensenich, Sue Ann Barry, and Elijah Yearick.

LOYALTY OATH

Mayor Timothy Snyder administered the Loyalty Oath to Stephen C. Lee (Borough Council First Ward, 4-year term), Kendrick N. Mobley (Borough Council Second Ward, 4-year term), Christine L. Sensenich (Borough Council Third Ward, 4-year term), having been duly elected to Council.

ELECTION OF OFFICERS

Mayor Snyder presided over the meeting and called for the reorganization of Council for the 2022-2023 term. Mayor Snyder called for nominations for the office of President. Sensenich moved, Lee seconded to nominate Weaver to the office of President. There were no other nominations. Nominations were closed and Weaver was unanimously elected as President. Mayor Snyder called for nominations for the office of Vice-President. Sensenich moved, Mobley seconded to nominate Lee to the office of Vice-President. There were no other nominations. Nominations were closed and Lee was unanimously elected as Vice-President. Mayor Snyder called for nominations for the office of Chairman pro tem. Sensenich moved, Mobley seconded to nominate Greiner to the office of Chairman pro tem. There were no other nominations. Nominations were closed and Greiner was unanimously elected to the office of Chairman pro tem.

APPOINTMENT OF BOROUGH POSITIONS

The Mayor relinquished the Chair to President Weaver. On a motion by Sensenich with a second by Greiner, Sue Ann Barry was unanimously appointed as Secretary/Treasurer. On a motion by Sensenich with a second by Greiner, David Miller/Associates, Inc. was unanimously appointed as Borough Engineer. On a motion by Sensenich with a second by Mobley, Barley Snyder was unanimously appointed as Borough Solicitor. On a motion by Sensenich with a second by Mobley, Michael Enck and Gary Cassady were unanimously appointed to the UCC Board of Appeals.
